Youth are engaged in school via Rochester Public Schools. All school related activity is referred to and connect with their home school so they don't miss out on any credits

Those there are connected with psychiatric care via practitioners that come from Mayo

Outreach efforts with the school systems-shared information kits with education district staff will share with the school districts they serve, staff dropped off packets to schools near their home, etc.

They have created a video tour so that one does not need to go there to know what it is likevideo was shared

CIVIL COMMITMENT- County Updates AND changes in Mayo's Commitment Policy-Mower County had a meeting with Mayo, Mayo initiated the connection, just the start of this needed conversation

Discussing acuity at time of presenting at Mayo and then ongoing acuity- such as what are they looking for, what information and details do they need, etc.

Robust discussion with full acknowledgement as to why Mayo felt they needed to take such action while also fully acknowledging the issues with this plan and how the person is at risk,, etc.

Some counties are meeting with Mayo to review specific situations that have taken place where the county feels the person was still in need of that level of care

Some counties have a Crisis Alert form that they use when there is a revocation, or to give LEO's a heads up. Use of such a form would need County Attorney approval- this will be sent out
